Important Information

Eligible vehicles

The insured vehicle must be:

- A car, motorcycle over 150cc, motorised caravan, minibus, light van, estate car or 4x4 sport utility vehicle registered in the United Kingdom, the Isle of Man or the Channel Islands. Towed caravans or trailers are not covered unless the additional premium is paid.
- No more than 15 years old at the date you buy the policy.
- Not more than 3,500kg in weight (including any load), 7 metres long, 3 metres high and 2.3 metres wide.
- Not carrying more than the recommended number of passengers (maximum being 8 including the driver).
- Kept in a safe and roadworthy condition and serviced in accordance with the manufacturers specifications.

We can also provide cover when towing a caravan or trailer up to 15 years old.

Eligibility

Euro Plus is available to residents of the United Kingdom, the Isle of Man or the Channel Islands.

'Cooling off' period

Should the cover not meet your requirements after you have purchased the policy, you can return the documents within 14 days of receipt. Provided you have not travelled or made or intend to make a claim, your premium will be refunded in full.

Claims
