Cover is for an unlimited number of trips per year, with a maximum trip duration of 45 days (minimum duration 24 hours).

#### Area:

UK and European trips.

Europe is defined as all countries west of the Ural Mountains, the UK, the Channel Islands, Algeria, Morocco, Tunisia, Turkey, the Azores, Canary Islands, Madeira and Mediterranean islands (excluding travel to Libya, Lebanon, Israel, Egypt and Syria).

UK is defined as England, Scotland, Wales, Northern Ireland and the Isle of Man.

#### Insured Vehicles:

Any passenger derived commercial vehicle registered in the UK or the Channel Islands of recognised manufacture which is not more than 7 years old at commencement of the journey (vehicles aged 8 – 15 years may be covered on application, but only when this is confirmed in writing) and for which cover has been purchased (except as notified to and agreed by P J Hayman & Company Ltd in writing). The insured vehicle must be kept in a roadworthy condition and serviced in accordance with the manufacturer's specification and must not carry more than the recommended number of passengers.

### Rating Basis

Annual premium based on the estimated number of 'coach days' during a 12 month period in Europe or in the UK for vehicles under 8 years old.

Vehicles 8 to 15 years may be considered (subject to a satisfactory claims experience) on application. In this event the premium per day will be increased by 50%.

Premiums based on the number of days in Europe or in the UK:

#### European trips

Vehicles under 8 years old.

£21.08 per coach day + IPT = £22.35

Minimum premium £150.00 + IPT = £159.00

#### UK trips

Vehicles under 8 years old. Trips must include at least 1 overnight stay.

£10.55 per coach day + IPT = £11.18

Minimum premium £81.10 + IPT = £86.00

IPT (Insurance Premium Tax) is included at the current rate.
